



Installation Guide





CONTENTS

- B. (1) Passenger Side Intercooler Hose (Hot Side)
- C. (1) Driver Side Intercooler Hose (Cold Side)

- E. (3) W-Style Hose Clamp, 52-76mm
- F. (1) W-Style Hose Clamp, 59-83mm



DISASSEMBLY

- 1. Vehicle off and cool.
- Disengage the retaining clips from the factory intercooler connectors on both sides.
 Disconnect factory intercooler hoses from the intercooler.
 (Fig. 1 & 2)







 For both sides, disconnect factory intercooler hoses from factory intercooler pipes. Remove both factory intercooler hoses. (Fig. 3)





 Remove the two bolts securing the intercooler to the support brackets. Carefully lift the factory intercooler to unseat the grommets from the lower support. Remove factory intercooler. (Fig. 4 & Fig. 5)







INSTALLATION

 Transfer the two factory square peg grommets and the two round grommets with steel insert onto the PPE Intercooler. (Fig. 6)



Attach the two Aluminum
 Connectors (D) to the PPE
 Hot and Cold Side Intercooler
 Hoses, (B & C) with two Hose
 Clamps (E). Make sure the
 Aluminum Quick-Connects are
 installed to the correct end of
 the hoses. (Fig. 7)



 Install PPE Intercooler onto the lower support. Make sure that the lower square grommets are fully seated securely. Reinstall the two bolts removed from Step 4. (Fig. 8)





- 8. Install both PPE Intercooler
 Hoses to factory upper plastic
 intercooler pipes. Use the
 larger Clamp (F) on the cold
 side connection. Install both
 Intercooler Hoses to PPE
 intercooler by connecting
 the Quick-Connects to the
 Intercooler. Tighten all clamps.
 (Fig. 9 & 10)
- Adjust the positioning of the anti-abrasion sleeves over the intercooler hoses, secure sleeves with zip ties.
- Place the supplied CARB E.O. label on a clean, visible surface under the engine hood. PPE recommends using the top side of the fan shroud.
